All purchases must be made within the Promotion Period to qualify and may be completed via phone, email, or enquiry form.

2. Eligible Services

Eligible services must be associated with:

- **Selective Entry High School (SEHS)** entry exams preparation (Year 9 or Year 10 entry), and/or
